APSEMO

1. Released PDRPMC-APSEMO ADVISORY- 2026 – 12.
2. Maintained 24-hour PDOC operation and monitoring.
3. Consolidate situational reports from the LGU’s and response clusters.
4. Released updates and provided media interview for public awareness and information.
5. Continuous monitoring with PHIVOLCS on Mayon Volcano status.

PROVINCIAL HEALTH OFFICE

1. The Operations Center (OpCen) hotline remains fully operational.
2. The Provincial Health Office’s official Facebook page continues to serve as a key platform for the dissemination of health advisories, public information, and online health promotion materials, particularly those related to the ongoing activity of Mayon Volcano.
3. Conducted WASH to all identified evacuation centers at First District.
4. Conducted disease surveillance by the Provincial Epidemiology Surveillance Unit (PESU) on First District evacuation centers which reported the following cases:
 - Three (3) with Acute Respiratory Infection
 - Two (2) with Skin Allergy
 - One (1) with Conjunctivitis
 - One (1) with Fever
 - One (1) with Headache
 - One (1) with Toothache
 - One (1) with Open Wounds and Bruises
 - One (1) with Abdominal pain
5. Provided services in Basic Hygiene Education, Nutrition management, and MHPSS.
6. Continuous monitoring of evacuation centers
7. Provision of medical and public health services
8. Replenishment of medicines and supplies, as needed.
9. Continued coordination with partner agencies and LGUs.

MDRRMO GUINOBATAN

1. Inform the LCE about the Mayon Status
2. Continuous coordination with BDRPMC and evaluation of families living outside the 6-km PDZ.
3. No entry on the 6-km PDZ with PNP and Barangay Tanods detailed on the entry point.
4. Information Dissemination on Mayon Volcano Alert Level.
5. Continuous monitoring of Mayon updates.
6. Monitoring of Mayon volcano air quality
7. Phil. Army in place for further instructions.
8. On blue alert status and stand by alert.
9. Strict compliance and implementation of MDRPMC Advisory No. 3 s. 2026 adopting PDRPMC – APSEMO Advisory – 2026 -12.

- 10. Strict compliance to MDRRMC ADVISORY No. 6 s. 2026 – set of advices to follow regarding the Mayon Volcano Alert Level 3 Ashfall.
- 11. Guinobatan is under the State of Calamity based on the resolution approved by the Sangguniang Bayan.
- 12. Assistance provided/distributed to farmers affected by the ashfall in the Municipality.

CDRRMO LIGAO CITY

- 1. Coordinated with the barangay DRRM Officials and ensure the activation of the BDRRM Council.
- 2. Regular monitoring of the evacuees, and delivery of potable water and refill of gas tank.
