I. BACKGROUND INFORMATION

Strombolian activity with short-lived lava fountaining and lava effusion; lava flow on Basud (3.8 km), Bonga (3.2 km), and Mi-isi (2.1 km) gullies; The crater glow is fair (naked eye). The plume is 750 meters above the crater; Moderate emission; northeast drift. It has short-term deflation of the edifice with shorter-term inflation on the northeastern flank [PHIVOLCS]

PROVINCIAL HEALTH OFFICE

1. The Operations Center (OpCen) hotline remains fully operational.
2. The Provincial Health Office’s official Facebook page continues to serve as a key platform for the dissemination of health advisories, public information, and online health promotion materials, particularly those related to the ongoing activity of Mayon Volcano.
3. Distributed 2,000 facemasks and 69 gallon of 6L Absolute mineral water to the Rural Health Unit (RHU) of Tabaco, malilipot Tent City , Camalig EC and Ligao evacuation Center with 21 Gallon of Absolute mineral water .Assorted medicines for Buang Evac. Center, Ligao and Camalig Evac. Center.
4. Conducted disease surveillance by the Provincial Epidemiology Surveillance Unit (PESU) on First District evacuation centers which reported the following cases:
 - Four (1) with Acute Respiratory Infection
 - One (1) with Itchiness (Body part)
 - One (1) with redness (Body part)
5. Purok Pangkalusugan conducted health services
 - 25 Dental services
 - 55 eye check up
 - 1 CBC
 - 1 Urinalysis
6. Convened meeting on updates and monitoring findings of Rapid Health Assessment Team.
